## Your Regional Board at Work

### November 4 Fall Board Meeting at Shangri-La

Your elected board members met on 11/4 to discuss critical issues affecting the region, to set priorities for 2018, and to approve a budget for the coming year. We thank the of you who came to watch and to participate in the discussions.

- The morning session was devoted to a couple of workshops focused on revising the Scholarship program, reviewing the Kid Summer Camps, and setting priorities for the Membership Marketing committee.
- The **Scholarship** team proposed opening up the annual Scholarships to adults going back to vocational or trade school and to those who may need just a class or two to get a new job skill. Previously the focus was on high schoolers who were going to a 2 or 4-year college only. This also means the eligibility and the judging process needs to be totally re-written. Everyone agreed the applications should be available on-line and not just written-and-mailed as was the case previously. These changes will require some changes in our regional by-laws and procedure manual and so the committee will make a full report with recommendations at the next board meeting in March, so things will stay the same for 2018.
- The Board agreed the **Kids Summer Camp** program needs to continue, even though attendance has dwindled the past few years as the number of teens and pre-teens at the clubs who are interested has dropped. Some clubs still have clusters of kids interested so the camps will be held there. Mountain Air Ranch in Colorado and Glen Eden in California are both considering hosting 4-day Camps next summer. We are encouraging all the clubs to set aside tuition and travel expenses in their budgets to help send their kids and grandkids to these very fun events. More details will be available after the first of the year.
- The Marketing and Public Relations team is looking to expand the number of **trade shows** we attend next year as these have proved to be a great way to educate the public about social nudism. We will again be at the Quartzite RV show in Arizona in January, the LA Travel Show in California in February, the California Parks and Recreation show in March, and the **Earth Fair** in San Diego's **Balboa Park** (the largest free annual Earth Day environmental fair in the world) in April. We also will have information booths at various clubs throughout the year, so members can learn more about what AANR does for them. We are looking into various charity walks in other cities, such as Relay for Life and Avon 39 and board members will be looking into these events in their cities to see if we can get a nearby club to participate. AANR-West will once again be co-sponsoring the Los Angeles World Naked Bike Ride in June, and we hope we can expand our involvement into other WNBR events around the region.
- June will be **Women in Nude Recreation Month** and all clubs are encouraged to add special events or workshops for their women members and guests. Several clubs in the region do women-only workshops on a quarterly basis with very successful results. One club does an afternoon offsite visiting a Korean Spa. We will be sending out suggestions to you in coming months.

During the afternoon session, we reviewed the **Sports program** we began last year by linking the various 5k Runs held at different clubs into a multi-club series with prizes for those who participate in all of the races. We may also expand the Summer Games program, currently held at Olive Dell each year, into a multi-club series that will add volleyball, tennis, and other sports so that a club trophy can be awarded for best overall team.

The Board also agreed to establish a permanent address for the region that will not change every time there is a new president or treasurer. This has been confusing to our insurance carriers and others who want to send us information. We will be announcing this probably in next month's newsletter and correcting our letterhead and business cards to reflect this permanent change.

Finally, the **2018 budget** was negotiated and approved to fund all of these activities (and more). Everyone left the meeting feeling really good about the coming year.

## Did you Know?

### The AANR Participating Business Program

- This is designed to affiliate nudist-friendly businesses, such as Bed and Breakfasts, Motels, etc. who do not have AANR members per se. Like member clubs, they receive a plaque for their front office so that clients know that they adhere to our principles and standards. Think of it like the "Good Housekeeping Seal of Approval." Like clubs, they must apply to AANR for affiliation. The cost for a business to belong to AANR is \$300 for the first year and \$200 for each year renewal.
- Also, these businesses can promote their activities by having their literature included at our periodic tradeshow booths. They may also want to donate to one or more of our periodic tradeshow drawings, festival raffles, or the annual GAT auction, for "a free two-night stay at our B&B," for example.

### The AANR-West Club Loan Program

- AANR-West clubs may receive one interest-free loan per year, not to exceed \$5,000.00 each. The purpose for this is to assist improving facilities or perhaps acting as seed money for a new project that will attract new members. AANR has its Glen Miller program which similarly can provide interest free loans up to \$10,000 for "100% clubs."

### More about the Co-op Advertising Program

In the October 2017 issue (last month), we discussed how Cooperative Advertisement Reimbursement program works. Some additional things perhaps you did not know:

- AANR West chartered 100% clubs may be reimbursed either 50% of the cost of qualified advertising, the amount not to exceed \$400.00 per year per club, or 25%, the amount not to exceed \$1,000.00 per year per club.
- AANR International has a similar program with similar guidelines. By submitting to both, a club could "double dip" and possibly get a rebate for nearly 100% of their cost. Advertising does not need to be in the print media. If a club bought coffee cups with the AANR or AANR West logo, for example, they could be eligible for reimbursement up to a certain dollar amount.

## Awards for Man/Woman/Family of the Year

It isn't too early for all the clubs to start thinking about who they may want to nominate for next year's Man of the Year, Woman of the Year, and Family of the Year. We seek to honor those unsung heroes who go that extra mile all the time but who never seem to get recognized for their efforts. Other awards are handed out for excellence in

Sports, Government Affairs, and Hall of Fame (Lifetime achievement). Deadline for submission is not until next May but we want you to start thinking about this early.
