# 2018-2019 GOALS - DISCUSSION

- Gary Mussell:
  - In a general sense, the board should be looking at some new ideas to attract new members from places not tried until now. In the public's eye we represent the social nudist movement, not just AANR.
  - We need to work on the western region's trademarks and collecting all our legal documents into one place, so we are legally covered.
- Claudia Kellersch:
  - We should sponsor WINR-specific events to get women comfortable at destinations such as Korean Spas, pampering workshops at the clubs, "bring a friend to a workshop" promotions, and Earth Day. We might also want to consider establishing a Speakers Bureau to speak at community service clubs (Kiwanis, Rotary, etc.)
  - At the next convention we should host a "how to take/edit a video" workshop.
  - We should establish rapport with various Beach groups and bring spiffs there to hand out.
  - We should translate our brochures into Spanish as that would help is in Mexico and among potential members of Latin American origin.
- Don Giles:
  - We need better and direct communication with our members and Associates as not everything can be solved via email. The Western Sun is a great idea, but we also need to get out from behind our computers to do meetings at the clubs. Spiffs will ne needed for these club visits and should be budgeted for 2019.
  - Bev Price reminded the meeting about the New Mexico Fund. It was assigned to AANR-West by Marion and Ramie Stelts in 1992 from club that was closed. These funds are specifically to assist in opening a new landed club in New Mexico. There is about \$4500 available.
- Mike Glinzak:
  - Look into new ways of targeting our club and regional events through social media, as opposed to just posting general advertising there.
- Ricc Bieber:
  - Our photos in club brochures and on social media needs to stop showing empty swimming pools and nobody on the lawns. We need to show people having fun!

- Nude Rec Week is not being promoted well at the region or club level. We should gather a list of activities early and start letting the local press know.
- Can we go back into the colleges to try to start some local clubs there?
- I agree we need to be at more trade shows as they have proved a great way to introduce AANR to the general public.
- I agree we need a stronger club liaison program and more person-to-person interaction.
- Associate outreach is important. Western Sun and Passport program are a good start.
- The Board discussed the Passport Program again, and the cost of printing and having the clubs repay the region was of concern. A consensus of the Board sees this as a member benefit that the region should pay for printing out of its own budget and not the members at the club level unless the clubs themselves want to charge something.
- Rolf:
  - He reminded the Board there is an upcoming unbudgeted expense coming up in August for the Topless Festival in Colorado that is being deemed part of WINR. The Board agreed no motion was needed as the funds will be coming out of the existing WINR budget.
  - The Board discussed the merits of returning to the Quartzite show in Arizona next January. Cyndi said this show has evolved into more of an RV sales show opposed to an information opportunity. After discussion it was the consensus of the Board that AANR-West should pull out of the 2019 show and reevaluate it again in a few years.
  - Gary urged everyone to look in places for new local trade show opportunities (example: local Earth Day events) or other places (World Naked Bike Ride, Free the Nipple rallies) we can showcase AANR.
- Treena:
  - I support the ideas for more and more varied women's workshops. One idea: a burlesque night was a successful fundraiser (raised \$1200 for charity) at a local club.
- Andy:
  - We need to be on more social media sites.
  - We need more targeted social media posts that link Facebook, Twitter, etc back to a specific page on the aanrwest.org web site.

Russell Lucia and Rolf Holbach spoke to the Board about the importance of the next few months to take these ideas suggested above, prioritizing them, and converting them into projected costs and budgets.
